Water Use Efficiency Tips:

Turn water off while brushing your teeth and rinsing your dishes.

Cut the time per shower by a few minutes and save up to 150 gallons per month.

Wash vegetables and fruits in a pan of water instead of running water; then use the water for watering plants.

Insulate hot water pipes to save water and energy.

Clear Creek MHP receives its water from 1 groundwater well. Well #1 is 100 feet deep and provides 32 GPM.

Contaminants in drinking water:

Drinking water including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the number of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water hotline (1-800-426-4791).

Sources of drinking water (both tap water and bottled water) can include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animal or human activity.

Contaminants that may be present in source water include: **MICROBIAL CONTAMINANTS**: such as viruses, parasites, and bacteria that may come from sewage treatment plants, septic systems and agricultural livestock operations or wildlife. **INORGANIC CONTAMINANTS**: such as salts and metals, which can occur naturally or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining and farming. **PESTICIDES AND HERBICIDES**: which may come from various sources such as agriculture, urban stormwater runoff and residential uses. **ORGANIC CHEMICAL CONTAMINANTS**: Including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production. They can also come from gas stations, urban stormwater runoff, and septic systems. Radioactive contaminants, which can occur naturally or result from oil and gas production and mining activities. **SOURCE PROTECTION INFORMATION**: The Department of Health Office of Drinking Water has compiled Source Water Assessment Program (SWAP) data for all community water systems in Washington State. Lead in Drinking Water: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Clear Creek MHP is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Glossary

Please note samples have different compliant periods; results in this table reflect the most up to date results with DOH.

MCL (Maximum Contaminant Level): The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG (Maximum Contaminant Level Goal): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

AL (Action Level): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

MRDL (Maximum Residual Disinfectant Level): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Secondary Maximum Contaminant Level (SMCL): These standards are developed as guidelines to protect the aesthetic qualities of drinking water and are not health based.

State Reporting Limit (SRL): If it reaches this number it must be reported.

IOC (Inorganic Chemicals): Mineral-based compounds.

Ppm: Parts per million

Ppb: Parts per billion

N/A: Not applicable

µmhos/cm: Micromhos per centimeter.

NTU: Nephelometric turbidity units

Cryptosporidium: A microorganism commonly found in lakes and rivers which is highly resistant to disinfection. Cryptosporidium has caused several large outbreaks of gastrointestinal illness, with symptoms that include diarrhea, and/or stomach cramps. People with severely weakened immune systems are likely to have more severe and more persistent symptoms than healthy individuals.
